Job Title	MyBnk Freelance Trainers - London
Location	Training programmes are delivered
Setting	We work with children and young people aged 5 – 25 across a range of school and community based settings. Freelance trainers often but don't have to specialise in working in either schools or community settings with those 16-25. We are interested in receiving applications from individuals with experience in any area, but particularly those wanting to work with the young adult age group.
Duration	Freelance - Minimum commitment 12 months
Fees	Rate for one session (typically 2 hours) workshop £120, rate for full day workshop £200 Rates are inclusive of travel within the M25.
Closing Date	We accept applications on an ongoing rolling basis

- To young people in primary schools across London
- To young people in secondary schools across London
- To young adults in one of our 'Money Houses', simulated flats situated in the boroughs of Greenwich, Newham, Westminster, Haringey (groups up to 8)
- To young people and young people in community settings.
- Virtually to groups of young adults aged 16 15 (Groups of approximately 8)

## You will be

- using your relevant experience and passion of working with groups of young people/ adults, to not just deliver, but bring our content to life; effectively engaging learners with a delivery style that is clear, concise, energetic and inclusive; be that virtually or in person,
- Supporting MyBnk to deliver the best possible outcomes for young people by both providing and gathering feedback on our programmes, including administering and completing monitoring and evaluation questionnaires.
- Supported to deliver MyBnk programmes to an exceptionally high standard and become a financial education expert; undertaking initial training (renumerated at a reduced rate), continuing your professional development, updating your subject knowledge and sharing good practice
- A valued representative of MyBnk, upholding MyBnk's mission, ethos and reputation.

## **Person Specification:**

We want to ensure that our staff represent the wide range of young people they support so they can provide meaningful, authentic education opportunities. We therefore encourage applications from those with lived experience of disadvantage, and those of an ethnic minority background. MyBnk will not discriminate, ensuring that each candidate is assessed only in accordance with ability to perform the role.



- Confident in delivering programmes to young people you're meeting for the first time with the ability to forge
  relationships quickly and effectively within settings that could include; mainstream classrooms, community
  centres, alternative education organisations (e.g., Pupil Referral Units, YMCAs) or virtual classrooms
- Able to effectively engage diverse groups of learners using a variety of teaching techniques and accessible
  content, to ensure a positive and inclusive learning environment content is accessible; this could include
  groups that vary in age, background, ability or specific education needs.
- Be willing to travel across Greater London or have the necessary equipment / home set up to deliver virtual workshops
- Some of our courses are accredited and require you to have a Have a Level 3 AET or PTLLS qualification
  or be willing to carry out this qualification with the support of MyBnk upon employment prior to delivering
  them.
- Have a fluent command of English and have the right to live and work in the UK.

## **About being a MyBnk Freelance Trainer**

We currently need trainers to deliver our range of programmes. You will start with one and have the opportunity to train on further programmes, based on your experience, preferences and availability.

The amount of freelance work you are offered is dependent on your flexibility, area of expertise and a level of seasonality. A booking typically is for 4 – 5 hours in one day.

You will be provided with comprehensive training to deliver the MyBnk programmes including:

- Core subject knowledge: an e-learning programme followed by an assessment
- Initial and ongoing programme training; both content and delivery

Training days are remunerated at a reduced rate.

Offering education of the highest quality is key to achieving our mission. Therefore, your working as a freelance trainer for MyBnk is dependent upon passing this training process, aswell as continuing to meet our quality standards in your programme delivery. We assess thisthrough young people and teacher feedback, as well as observation of your programme delivery.
